The client will open a bank account under the main **Martin Eksteen - Jordaan - Wessels cc** Agent account with Nedbank , (or its successor in title) which will be in the name of the client. The client hereby furnishes **Martin Eksteen - Jordaan - Wessels cc** with the necessary authority to transact on this account on his/her/their behalf subject to receipt of the client’s telephonic, written or faxed instruction.

Should the client instruct **Martin Eksteen - Jordaan - Wessels cc** to pay any amounts to a third party (individual or institution), the client hereby unconditionally absolves and indemnifies Nedbank (or its successor in title) and **Martin Eksteen - Jordaan - Wessels cc** from and against all and any loss, damage, costs and expenses which the client or any other person whatsoever, including any minor children, may sustain or incur, either directly or indirectly as a result of Nedbank (or its successor in title) or **Martin Eksteen - Jordaan - Wessels cc**, paying any amounts (as per client’s telephonic, written or faxed instructions) into the bank account / or per cheque to a third party.

The client understands that they will not be able to transact directly via other Nedbank branches or Head Office. All transactions must be addressed to and actioned by **Martin Eksteen - Jordaan - Wessels cc**. The client will receive confirmation of transactions on a monthly basis. Deposits and withdrawals must be received in WRITING or by FAX before 12.00 (at your dicretion). If received later they will be held over for processing to the next business day.

It is recorded that **Martin Eksteen - Jordaan - Wessels cc** is an accountable institution in terms of the Financial Intelligence Centre Act, No. 38 of 2001 (FICA) and is obliged to comply with he provisions of FICA, which provisions, inter alia requires **Martin Eksteen - Jordaan - Wessels cc** to establish and verify the identity of its clients. The client agrees to provide to **Martin Eksteen - Jordaan - Wessels cc** all of the supporting, verification and other documentation prescribed in terms of FICA and as required by **Martin Eksteen - Jordaan - Wessels cc** .

By offering the Corporate Saver product, **Martin Eksteen - Jordaan - Wessels cc** is rendering and intermediary service as contemplated in the Financial Advisory and Intermediary Services Act, No.37 of
